Sustainability Policy Statement

Purpose

Lusail International Circuit (LIC) is committed to being a global leader in sustainable motorsport venues by integrating environmental stewardship, social responsibility, and economic viability into all operations. This policy formalizes LIC's commitment to advancing sustainable development in line with Qatar National Vision 2030, international best practices including ISO 14001, ISO 20121, ISO 50001, UNFCCC Sports for Climate Action, and FIA Environmental Accreditation Program objectives.

Scope

This policy applies to all activities, permanent and temporary, within LIC's property boundaries and governs all stakeholders including employees, contractors, suppliers, event partners, teams, spectators, and volunteers.

Vision

LIC aims to be recognized as the region's flagship sustainable motorsport venue, showcasing Qatar's leadership in renewable energy adoption, circular economy principles, carbon neutrality, waste reduction, and community engagement.

Guiding Principles

- **Compliance & Leadership:** Adhere to all applicable environmental, social, and governance regulations and lead sustainability initiatives within sport and motorsport industries.
- **Continuous Improvement:** Embed sustainability into organizational culture with regular monitoring, reporting, and verified improvements in environmental and social performance.
- **Stakeholder Engagement:** Foster collaboration and training among all partners and communities to promote sustainable behaviors and shared responsibility.
- **Resource Efficiency:** Optimize energy, water, and material use and prioritize renewable energy sources and low-impact transport.
- **Waste Minimization:** Design out waste, eliminate single-use plastics, incentivize reuse, recycling, and composting, and achieve zero waste to landfill by 2030.
- **Sustainable Sourcing:** Source local, certified, and responsibly grown food and materials, supporting circular economy principles and fair labor practices.
- **Community-Centric Approach:** Respect cultural heritage, promote education, and create economic opportunities for the local community.

Implementations & Governance

- LIC's Sustainability Steering Committee comprising of the representatives from Senior Management along with the Sustainability manager shall oversee implementation, conduct annual performance reviews, and publish annual sustainability reports.
- All procurement and operational contracts shall include sustainability clauses reflecting this policy and its supporting documents.
- Training programs and communication plans will be updated annually to support stakeholder engagement and compliance.
- A dedicated sustainability officer will coordinate related activities and act as the primary point of contact for sustainability across all LIC operations.

Reporting & Review

- Progress towards targets will be measured using validated data and reported to LIC management and relevant accreditation bodies.
- This policy will be reviewed and updated annually or as required to align with evolving regulations and best practices.

This Sustainability Policy is supported by specific operational frameworks and guidelines including the LIC Sourcing Code, Sustainability Requirements for Catering Partners, and the LIC Sustainable Consumables Guidelines. These documents provide detailed procedures, standards, and expectations tailored for various partners and operational areas, and should be used in conjunction with this policy to ensure comprehensive adherence to LIC's sustainability commitment.
